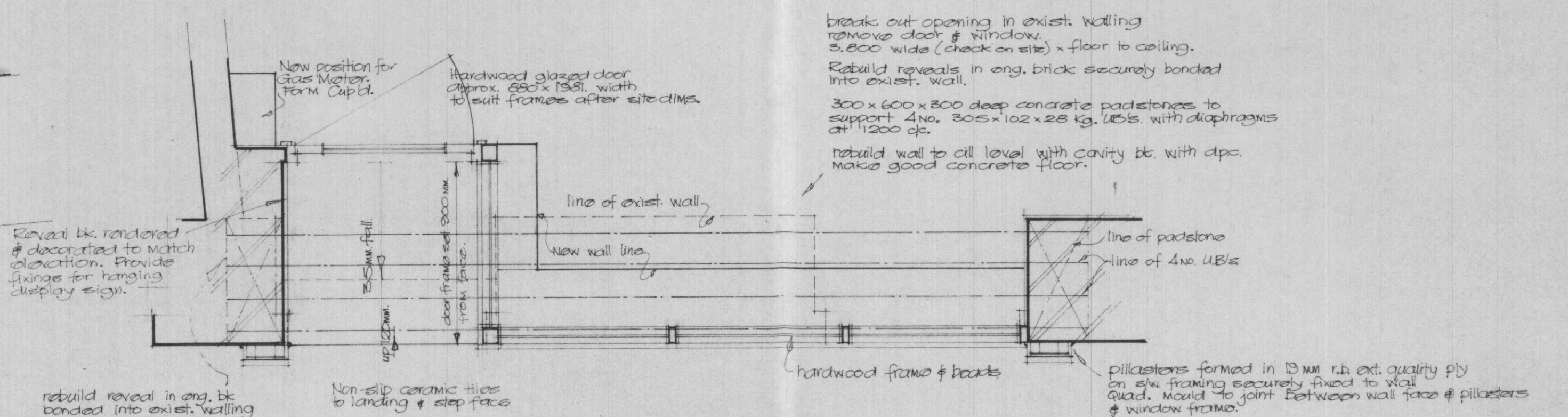
Front Elevation (north)

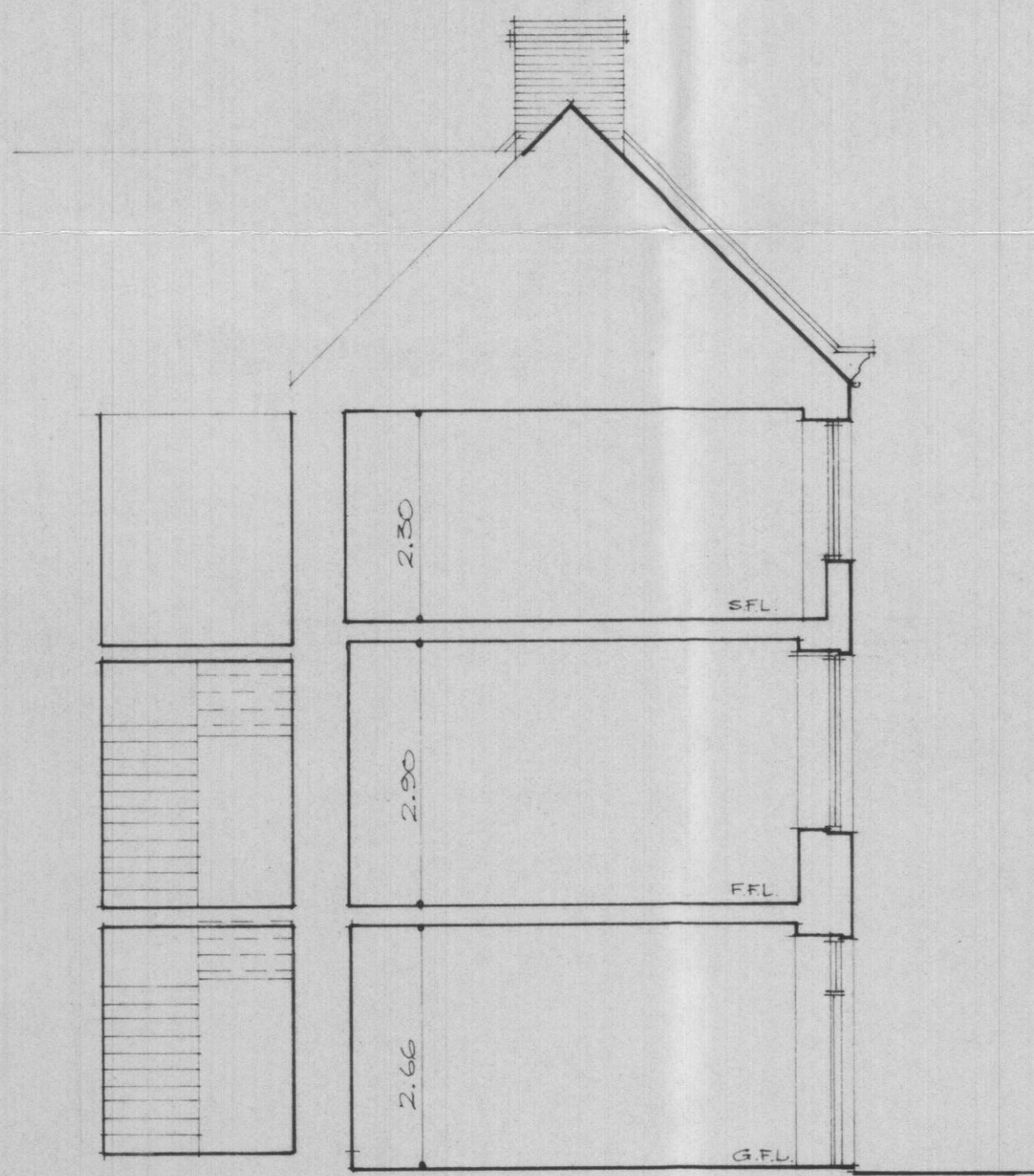
